- Kathy commented on her appreciation of the thorough notes.
- Sami commented that the information of the woman and color superintendents is very helpful and we should all pay close attention. He also shared the good news of more superintendents of color being added in the state.
- Meeting notes were approved.

## 3) 9:50 to 10:25 Updates on action items from the Jan 8 general meeting

a) BIPOC Student Voice Project - Neelam (9:50 to 10:15)

Neelam gave an update of the BIPOC Student Voice Project

### **Current state of the project:**

- We had low attendance at the first meeting in March
- We received feedback from students at the March session
  promotion needs to be more student friendly.
- Understanding that students are dealing with a lot during this time of the many challenges.

In-person, virtual, regional, reschedule?

## Suggestions:

- Recalibrate
- Early fall of 2022
- Plug into conferences already happening instead of a separate event?
- Bill youth expressed that this is an adult problem and don't want to talk about it with the adults
- Sonja need to send the message out in youth centered language. seek involvement from advisory groups. seek their assistance in promoting the event through social media. like Next up and its like
- Put together a group of youth to help with the planning and promotion
- Youth have the answers but they are feeling that their voices are not heard
- Go to where the students are and engage them in the planning

Shauna and Bill would like to join Neelam and Kathy in planning the next steps for the project.

b) Concerns of School board member candidate addresses being made public in the election process - Luhui and Rose (10:15 to 10:25)

Lu and Rose have been working on this project. Sami provided the updates. There are general concerns of safety of members of color safety serving on elected or seeking to serve on elected boards. Lu and Rose have collected information on the topic both from local and national practices. The legislators have also taken up the idea of address- redaction in discussion and they decided not to go forward with any legislative concept at this time regarding this topic. Sami indicated that there might be listening sessions about school board members safety early next year during the legislative session. Also a board members safety toolkit is being prepared and is expected to be released soon by OSBA in partnership with the Governor's office in response to the concerns the caucus members shared earlier last year.

OSBA has not been silent and has shared it with the Governor. OSBA funded a project - safety resource tool kit.

#### Discussion ensued:

- Continue to talk to advocates. Is working on drafting a bill. Need OSBMCC members to provide more specifics on what should be redacted.
  - Currently, it includes home address, work address, phone number to be private and less easy for people to access.
- Sonja recommends that we aim to work on a system that is consistent around the state instead of county by county.
- Bill reminded people that we should not have a false sense of security as there are many ways for people to track down an elected member's address.
- Satya agrees with Bill's point. We should look into a real solution for safety concerns and not a feel good solution.
- Linda echoed in agreement. Safety concerns are real. People are traumatized.
- Helen agrees with all the points and urges that we stay the course and recognize that it's one part of the changes needed to acknowledge safety concerns then add additional measures going forward.
- Kathy also acknowledged. Election worker protection bill makes it a misdemeanor that is passed. 2023 session is a good opportunity for us to testify

- Consider extending harassment concerns for local elected officials as well.
- Erika agrees that we need to spend time to continue the course. Safety measures for ourselves and look into improving the process and partners.
- Bill suggested that the League of Mayors would be a good partner.
- Sami recognized the good work that Lu and Rose are doing and asked for others who are interested in helping out to let him know.

### 4) 10:25 to 10:35 Updates of Caucus initiatives and accomplishments

#### a) NSBA Delegate Assembly and Statewide (Sami)

Sami was the minority delegate for Oregon. There were several constitutional amendments changes to NSBA including the addition of voting seats at the NSBA board for all Councils (the equivalent of Caucuses at NSBA). This will allow for a stronger voice for Urban, Black, Native American, and Hispanic Councils for the first time since NSBA's inception 80 years ago. The precedent of Oregon's Color Caucus having a seat on OSBA's board was highlighted in support of this change. Oregon and the Caucus were well represented at the NSBA convention. Attendees who were on the Caucus scholarship will be sharing their reports shortly. Sami welcomed Betty and acknowledged Betty as a great advocate for the Caucus when she was the OSBA Board President.

Betty is excited to see the Caucus thriving. She stepped aside from a school board seat and is now supporting 3 members of color serving and leading. She currently serves on the OSU Honors College Board. Betty shared the key components of the OSU Honors College. Advancing diversity is a key component and has put goals in place to actualize that priority. She encourages students of color to apply for the OSU Honors College. Explanation could be provided if they do not meet the GPA, SAT/ACT score requirements.
