## Agenda and Notes

#### 1) Welcome, Introductions and Dinner Social

- The meeting began with a dinner social at 5 pm
- Sami called the meeting to order with a welcome message and introductions
- Sami shared the mission of the OSBMCC and recognized members for their service and invited everyone to attend the workshop tomorrow to learn more about OSBMCC: our accomplishments and the work ahead

### 3) Approval of Bylaws Revision Proposal

- Proposed bylaws revisions (Version 1 shared October 28, 2022)
- Proposed bylaws revisions (Version 2 shared November 9, 2022)
- Neelam presented the proposed revisions
  - She highlighted the changes and provided rationale for the proposed revisions
  - She also shared the pending revisions:
    - language on compliance with open meetings laws and clarification on the definition of quorum
    - language to formalize the appointment/choice of OSBA board member, LPC representative, and NSBA delegate
    - looking forward to getting a response from the OSBA legal team in a couple of weeks
  - Neelam acknowledged members of the committee and invited folks to join the committee
    - current bylaws committee members are Neelam Gupta, Pat Morinaka, and Bill Graupp
  - Vidal Pena moved to approve the proposed changes as shown in the <u>Proposed bylaws revisions</u> (Version 2 - shared November <u>9, 2022</u>). Satya seconded the motion. Motion carried by unanimous vote.

- Sami asked to reaffirm the appointment of NSBA minority delegate and shared about the past practice and the newly passed OSBA board motion.
- Bill moved to appoint Neelam Gupta to be the NSBA minority delegate. Osvaldo seconded the motion. Motion carried by unanimous vote.

# 5) Approval of 2022-23 Budget

- Sonja presented the 2022-23 Proposed budget
  - She acknowledged the increased support from the OSBA Board
    - rationale for the increase include increased membership, student voice project, and funding opportunities for engagement at the national level
    - budget has opportunity for flexibility when needs change and arise
  - Kim Brick moved to adopt the 2022-23 proposed budget. Aaron Munoz Gonzalez seconded. Motion carried by unanimous vote.

### 6) Student Voice Project

- Neelam provided a brief overview of the background and the why behind the project that came about a year ago. Engage to Change was invited to facilitate the project with an intention to offer a series of sessions for students. However, we did not have a good turnout for the first planned session. It was determined that we should organize an advisory team of students to help organize and plan the efforts moving forward. Recruitment has been underway and is ongoing. We welcome caucus members to continue to help with recruitment. We need student input in advising on how best to move the project forward.
