## V. Old Business

#### A. Financial Report

The corrected 2024-2025 financial budget was presented to the assembly. A total of \$25,000 was the starting balance not \$20,000.00. The current actual balance is \$22,671.43. This does not include the scholarships that were awarded for the conference attendance.

Risteen Follett made a motion to approve the corrected Rural Caucus financial rep Ed Dressel seconded the motion Vote: Unanimous approval

#### B. 2024-2025 Budget

The Leadership Assembly discussed ways to spend the corrected budget.

- 1. Marketing materials such as badges, shirts, etc will have budget up to \$2,300. Ed Dressel volunteered to be the head of the committee to purchase more marketing materials. Kris Lachenmier and Mary Anne Crandall volunteered to be on the marketing committee.
- 2. Scholarships for board training will now be increased to 8 @ \$1,500 each. We now have 16 applicants for scholarships

Risteen Follett made a motion to reallocate funds for marketing of \$2,300 and 8 @ \$1,500 each scholarships for training

Anber Nelson seconded the motion

#### C. Membership Update

Nichole Schott stated we now have 77 registered members. The Rural Caucus added 16 new members from the annual convention.

### D. 2024-2025 Board Training Scholarships, including criteria for selection

The Rural Caucus voted to increase the total number of board training scholarships to 8 @\$1,500 each. There are currently 16 applicants. They will be chosen by random drawing.

#### E. November 8, 2024, Business Meeting Update

The Rural Caucus business meeting was held at 7AM – 8AM on November 8, 2024, at the annual convention. There were many more participants than expected and it was a huge success.

#### F. Annual Convention Workshop Update

The Rural Caucus held a workshop in the afternoon of November 8, 2024, at the annual convention. The workshops were a resounding success with lots of participation. The members noted that we will need a larger room next time and maybe more time allotted for discussion. A form for participants to tell their stories and maybe a video or pictures would be a good addition.
