## (5:03) State of the Caucus - Sami Al-Abdrabbuh

Sami delivered some remarks about the state of the caucus, which included the following:

- The state of this Caucus is a state of strength, resilience, state of growth, a state of heavy emotional labor as we serve our communities during these difficult times. We are in a state of transformation and outstanding membership growth.
- Achievements:
- Policy and legislative wins including the successfully advocating for HB 2001 which "Requires school district that is making reductions in educator staff positions to retain teacher with less seniority if teacher has more merit and if retention of teacher is necessary to maintain school district's diversity ratio." and successfully advocating for HB 3294 which "Requires every public education provider to provide certain feminine hygiene products at no cost to students".
- Stronger relationships with LPC \& reps and senators
- In preparation for the short session ahead, encouraged caucus membership to continue reaching out with legislative goals and objectives.
- We were advocating for students, which included working with Parkrose students and OSAA in support of students' voices. Our students were empowered to share their voices and change the language for OSAA rules on athletics women of color.
- Advocating for BIPOC leaders and communities via resolutions and letters that reflect the values and goals of the caucus
- Professional Development
- We organized a session for the membership to outline goals on community engagement. (considerations the caucus membership shared from the June session is included with the minutes in a separate file)
- We continue to offer opportunities and platforms for us to share our experiences and common concerns.
- Peer mentoring opportunities for caucus members
- We are investing in opportunities to empower and celebrate student voices. Vice President Neelam Gupta will be sharing about a this project later this meeting
- Acknowledged that the safety of our membership, their families, and BIPOC administrators, teachers, students, and their families are front and center and a high priority for this caucus. He stated that caucus leadership will continue its advocacy on this issue and invites members to continue reaching out with any concerns they are facing, or they hear about in their districts.

(7:15) Supporting BIPOC Student Voice Project - Neelam Gupta
Neelam provided an update on a new caucus project under development that will provide tools and resources to BIPOC students to strengthen advocacy capacity and infrastructure in Newberg and statewide. An Oregon Student Voice representative and Newberg school board members Brandy Penner and Ines Pena attended the October caucus leadership meeting to share information about how students are doing. Neelam has been connected to a Newberg school counselor who reported students are experiencing the trauma of recent racist incidents. Neelam and Kathy will meet with Engage to Change about designing and delivering trainings in early 2022.
