The **Southern Oregon Education Service District** serves approximately 45,000 students in Jackson, Josephine and Klamath counties. Our 13 component districts have 120 schools. The ESD has a general fund budget of \$106 million, with 90 licensed employees, 146 classified employees, five confidential employees and 31 administrators. The ESD's core services include partnering with districts to deliver special education services, providing school improvement services such as professional development and student career and technical education programs, and supporting school district offices with administrative services. We also offer informational technology, instructional support and home and alternative learning services.
